<input type="checkbox"/>	PI-ILLs with customised simplified patron forms. Make it easier for your patrons to search & submit their requests without mistakes. SHAREit V6 now includes a new easy drag & drop forms interface!
<input type="checkbox"/>	Privacy Disclaimer Notice. Provincial law requires a privacy disclaimer notice display before collecting personal details (eg. Last name) from your patrons.
<input type="checkbox"/>	The Patron Tracking feature for PI-ILLs includes customised login & status messages. Update within your ILL Admin > Patron Tracking to customise the messages or contact info.
<input type="checkbox"/>	Live Shelf Status checks save ILL Staff time by automatically deflecting requests for unavailable items allowing ILL Staff to focus on requests <i>you can</i> actually provide.
<input type="checkbox"/>	Lending Policy automatically rejects requests for certain formats or material types which saves ILL Staff time rejecting requests for formats you do not loan (eg. DVDs).
<input type="checkbox"/>	Guest Request ILL Limits for PI-ILLs. Libraries can set limits (eg. 5 active) based on patron name (First name and Last name) and the Password/PIN entered during request creation.
<input type="checkbox"/>	ILL 2nd notice. Add a notice to your patron forms, that displays after they submit requests, with important ILL delivery and restriction information (eg. fines; delivery expectations).
<input type="checkbox"/>	Branding of the SHAREit home page is available including library logo, contact information, and ILL Restriction information.
<input type="checkbox"/>	Search Resources for both Staff & Patrons should be reviewed yearly to make sure you're offering the best available search target defaults, including the newly available LAC Voilà Z39.50 search target.
<input type="checkbox"/>	Union Database (UDB) updates. When was the last time you uploaded your records to the UDBs? Frequent record uploads allow borrowers to accurately locate items available for ILL. Please contact us with suggestions or record errors for the upcoming Database Clean-up Project projected for 2020!
<input type="checkbox"/>	OpenURL. Item not available in your OPAC? Add an OpenURL link to Bibliocommons (or many other interfaces) that redirects patrons to SHAREit to locate search results instead.
<input type="checkbox"/>	Holiday Closures. Update your ILL Admin > Maintain Participant Record > Holiday List with any closures to deflect Lender requests while your library is unavailable.
<input type="checkbox"/>	Patron Email Notices. Save time communicating with your patrons about status updates using automatic Patron Email Notices (does not require PI-ILL). Ask us for assistance!
<input type="checkbox"/>	Staff Email Notices. If your site doesn't login to SHAREit daily, Staff Email Notices allows staff to receive notifications direct to their inbox about new requests and other important status changes.
<input type="checkbox"/>	Blocked Lenders List. Under your ILL Admin > Maintain Participant Record > Blocked Lenders your library can stop the ERTI Smart-build from automatically adding charging libraries (eg. UVic) to Lender List builds.
<input type="checkbox"/>	Recent Maintain Participant Record assessment of settings that impact software calculations/processes, including your Days to Respond (DTR), Days to Supply, Days to Return, Days Requests are Processed, Set Default Need-by Date, Owned by My Library , and many more.
